Typical Procedures:

- 1. Detergent Clean Outdoor unit, remove leaves and debris (if needed)
- 2. Install gauges and record operating temperature and pressures
- 3. Measure superheat and subcooling as required to inspect for refrigerant levels
- 4. Inspect all refrigerant connections and search for obvious leaks
- 5. Inspect all control circuits for proper operation
- 6. Inspect and test all wiring and wiring connections
- 7. Check voltage and amperage of motors
- 8. Inspect and test start & run capacitors
- 9. Check the auxiliary heat for proper operation
- 10. Inspect primary/secondary drain lines and overflow protection
- 11. Inspect and replace customer supplied air filter
- 12. Lubricate all moving parts where applicable
- 13. Inspect blower components
- 14. Visually inspect indoor coil
- 15. Test defrost initiation and reversing valve
- 16. Test "temperature split" between supply and return air
- 17. Test and explain proper operation of thermostat

Gas Equipment: (additional steps)

- 1. Inspect Heat exchanger and burners
- 2. Inspect pilot operations and gas pressure, adjust as necessary
- 3. Inspect flue draft
- 4. Test gas valve for proper operation
